## MINUTES

1. The Chairman welcomed all to the meeting and thanked everyone for attending.

Mike Price reported that following the good response from the Parish Consultation, it was agreed to form a 'PVH Refurbishment' steering group. The first action has been to contact Pitchford Estate to request an extension on the lease. On 29 September 1945 they were granted a 99 year lease, which has 25 years remaining. Without a further extension, any grant funding to help pay for refurbishment is unlikely.

The Insurance claim assessment has agreed that the kitchen wall damage is due to the subsidence, but not the splaying of the two Gable Ends, so the insurance will only pay for the kitchen wall. The committee will be contacting the Probation Service to get help with decorating. Bookings are on par with last year.

The tree will be staying as no evidence has been found that it is the cause of the subsidence.
