#### **MINUTES**

1. The Chairman welcomed all to the meeting and thanked everyone for attending.

#### 2. Minutes of the Previous Parish Meeting

- a. The minutes of the meeting on 14 May 2019 were accepted as an accurate record. No Annual Parish Meeting was held in 2020 due to the Coronavirus pandemic.
- b. There were no matters arising from the previous minutes.

#### 3. Police Report

PC Becky Hall, the new SNT police officer for Shropshire Rural East introduced herself. She said she would try to attend future Parish Council meetings. There are also 2 CSOs who cover the area, Lyn Birch and Jacqui Baldwin. There are low levels of crime in the area; most of the problems in the preceding year have been related to COVID lockdowns and the resulting increased numbers of walkers in the countryside parking irresponsibly. There have been some suspicious van sightings and PC Hall asked that people pass on registration numbers to the police if they encounter and suspicious vehicles. She asked the parish to get in touch with her regarding any concerns or events. *Action: Clerk to circulate contact details to all attendees*.
